CONSENT FORM

RELEASE, CONSENT AND INDEMNITY AGREEMENT (MINOR CHILD)

For value received, the receipt and sufficiency of which are hereby acknowledged, the undersigned, as the parent or guardian of the minor child listed below (the "Child"), does hereby executed this Release, Consent and Indemnity Agreement ("Release") as a condition to the Child being admitted to and allowed to participate in the camp set forth below (the "Camp").

1. I acknowledge the educational, recreational, and/or personal benefits accruing to the Child by reason of his/her participation in the Camp. I further acknowledge and understand that the Camp is sponsored by the Athletics Department of the University of Alabama in Huntsville and Royer Baseball Camps.

2. I understand that the Child will be participating in physical activity as part of the Camp and as such may be hurt or injured in such activities. I hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risk to the Child by participating in the Camp. However, I voluntarily authorize the Child's participation in the Camp.

3. I do hereby release absolutely, forever discharge, and covenant not to sue The Board of Trustees of The University of Alabama, the University of Alabama in Huntsville, Hunter Royer, Royer Baseball Camps and the officers, coaches, employees, contractors and agents of said parties (collectively, the "Released Parties") from any and all liability, losses, claims, demands, actions, debts, and expenses of every kind and nature for personal or bodily injury (including any resulting in death) or other damages which the Child or I may sustain from whatever cause during, arising out of, or as a result of such participation or any activity connected therewith, including without limitation the use of any vehicle or other conveyance or means of transportation. It is my intention to include the negligence of the foregoing parties or any of them within the scope of this Release and to except, by express limitation here stated, only wanton or willful misconduct by the same.

4. I do further consent to the Child's participation in the above described activity and hereby expressly, knowingly, and voluntarily assume for the Child all risk of personal or bodily injury to him/her from hazards normally incident to, ordinarily associated with, or reasonably foreseeable from such participation.

5. I do further agree to indemnify the Released Parties against any liability or loss sustained by any of them arising out of the Child's said participation.

6. I have agreed that the Child may be photographed, audio or videotaped at the Camp. As exclusive owner of such photographs and/or audio or video tapes and all propriety and copyright interests therein, Royer Baseball Camps shall have the sole and exclusive right to control and determine the use, display, performance, reproduction and dissemination of any such photographs and/or video tapes, including copies.

7. This Release shall be governed by the laws of the State of Alabama. If any provision of this Release shall be found to be unenforceable or invalid, that provision shall be severed from this Release. By entering into this Release I am not relying on any oral or written representation or statements made by the Released Parties, other than what is set forth in this Release.
